 - Asked Joel about the DEP about whether we still need all the testing. He was waiting on answer from them from 2017
 - Board suggests inviting Joel to a future meeting to further discuss and give the board an update
- 440 Still River Road

 - Conversation with Bill, looking to add a bedroom to the house, Bill has suggested speaking with an
 engineer for system to be sufficient to support the additional bedroom.
 - 1983 system, 3-bedroom permit, title 5 passed in 2015. Board in the past, if the existing system under today's calculation is supported, the Board has respected those calculations. Engineer's calculation is good for 5 bedrooms, 1250-gallon tank currently installed. Current size of the tank and trenches are adequate for 4-bedroom house.

 - Bill has the permits drafted, if the Board approves, Bill can sign the permit. The Board approves this
 measure.
