  - The proposed plan for permanent outdoor bathrooms is shared with the Board. These will be seasonal, mostly open on the weekends. There are 2 septic systems currently on site. Meter readings have been provided for review as well.
  - C.Rogers asks B.Brookings if there are any concerns with the flow numbers provided, B.Brookings does not see any problems with them as presented.
  - B.Brookings has questions on the existing tank and IA technology on the existing tank.
