- S.Powell also shared feed back from a realtors office: They are concerned with how this will affect
 properties in the process of selling at this time. Would the Board be open to a grace period for these
 properties.
- C.Rogers The Board can set an effective date to allow to time for the new regulations to take place.
- B.Brookings The results are good for 2 years, would that apply as well like Title 5 Regs? Board agrees
 yes.
- C.Slade proposes an effective date of July 1, 2022. C.Rogers agrees to that date. After July 1, 2022 any closing after this date the new regulations would apply.
- Is there a formal process for the sample? Is it the BOH agent or a preferred vendor?
- C.Rogers the owner is responsible for the sample and a copy would be provided to the Board. B.Brookings – like Title 5, The home owner can take the sample and send to a DEP certified lab.
