- Advisory Committee (131)
 - The Advisory Committee budget was adjusted to reflect \$18 for supplies and \$167 for dues.
 - Motion to approve the Advisory Committee budget for a total of \$185 by Bill Nickles, seconded by Bob Guerriero; **VOTED AND PASSED UNANIMOUS (4-0)**.
- Town Buildings (190)
 - Motion to approve the Town Buildings budget for a total of \$141,650 by Bill Nickles, seconded by Bob Guerriero; **VOTED AND PASSED UNANIMOUS (4-0)**.
- Dispatchers (299)
 - Motion to approve the Regional Dispatch budget for a total of \$212,921 by Bob Guerriero, seconded by Bill Nickles; **VOTED AND PASSED UNANIMOUS (4-0)**.
- Post Secondary Vocational Education (303)
 - The Post-Secondary Vocational Education budget is \$0 because Bolton will not have any students in post-secondary vocational education in FY24.
