### • Tobacco Regulations Update

- Beginning June 1<sup>st</sup>
- Tobacco alliance has sent the notices to BOH which is what they are sending to stores impacted by the changes

### Coronavirus Updates

- o KZina provides Update on DPH call
- Board has nothing to add on beach, as long as they follow the protocol with state guidelines and NABH guidelines
- o Bathing beach permit is approved NABH, water testing to begin
- o Bill indicates that Jim would like to speak with BOH Chairs on opening beaches. Suggests that Chris reach out to Jim if he does not hear from him.
- o Board has no issues with the proposed sign requiring face coverings to be displayed at town buildings

### Mosquito Response Update

- Committee has proposal for warrant article to join CMMCP
- o Committee still doing due diligence for other options for the town
- Scott has contacted a company which has an office in Nantucket (as part of a mosquito district) and has been in touch with someone at UMass for testing capabilities. They would not be able to do any mitigation, that would be up to the town of citizens
- o These are things to keep in mind, cost is a large factor when trying to piece these together
- o CR who would be in charge of handling the testing, mitigation if we do not go with the CMMCP?
  - Feedback from CMMCP is that they are still a compressive program
- State has proposed their own spraying program. This would take away from the surveillance that CMMCP would provide.
