# ACTION/DISCUSSION:

## **NEW TOPICS:**

- 626 Main Street
  - Brandon Ducharme from Davis Ross joins the call to discuss the property. The property at 626 Main Street is looking to add restaurant space, this additional space will impact the approved design flows. They are working to improve the PWS well. They'd like to expand the flow and see 2 new wells to be drilled on the abutting property and look to expand the septic system. They are targeting 150 additional seats for the restaurant. They have spoken to DEP regarding this and they are ok with the proposal. The 2 dining spaces would not be open at the same time, they would have separate serving times. The new dining space would be open and the entrance would be in the back.
  - B.Brookings suggests getting a count of the number of employees / patrons currently in the existing space and look at the numbers against the proposed numbers.
- Parks & Recreation Town Common
  - Lisa Shepple from Parks & Rec has joined the call to follow up on the town common well. The driller has spoken to Bill Brookings and deepening the existing well for irrigation well makes the most sense.
  - The Board approves and the driller will apply for the permit.
  - C.Rogers asks if there have been any water tests in the past and suggests a water test if there is nothing from recent years.
- 100 Wattaquadock Hill Road Nashoba Winery
  - They are proposing construction, currently working with conservation on the location as well.
- 100 Wattaquadock Hill Road Water reports
  - They continue to work with the state on the PFAS findings
- 642 Main Street
  - A plan from Ross Associates is shared, a proposal to replace the existing system. A few variance requests are included with this proposal as marked on the plan. Board approves the variances, Bill will proceed with the permits.
- 94 Drumlin Road
  - Long sewer line has been received for the property. Board approves.
- FY24 Budget
  - Board approves the budget prepared for FY2024 for Board of Health, Nursing and Landfill.
