January 2022 COA Meeting Outreach/Program Report

December was a great month, there were an abundance of programs and activities that were enjoyed by many. Most of our January programs are on hold because of the Community Room being closed. Off site programs and activities are still being held. I am looking to schedule some Zoom programs in February. With winter weather and Covid, zooming may be the safest option.

Fuel Assistance is going well. We have a good balance in the account and should start receiving donations from the Census mailer soon. I have mailed the 16 applications to date. I have also promoted the program in the Independent and on social media to spread the word that we have this program for Seniors who may need a hand with heat this winter.

Bolton Volunteer Fire Association is still taking names of seniors who would like a bucket of sand delivered.

Deadline for the February Newsletter is this Thursday, January 13th.

Mart pilot program is still moving slow. I am using their software exclusively for ride booking and dispatching, however there are still many glitches that is making the end of the month reporting a challenge. There are stakeholder meetings on a regular basis where questions, comments and concerns are addressed and we are not the only COA who is experiencing issues. The ride sharing grant we got through Valerie/MAGIC is going well. We have used that option 3 times when our van wasn't available. The group is conducting a transportation survey for all those without a vehicle of their own in Bolton. The link is in the newsletter and I have a few paper copies available. If you know anyone who doesn't have their own transportation, their input would be greatly appreciated.


