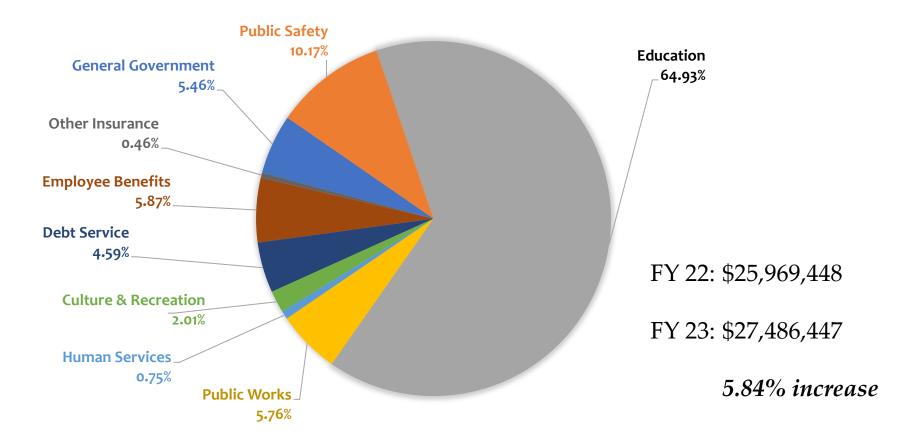

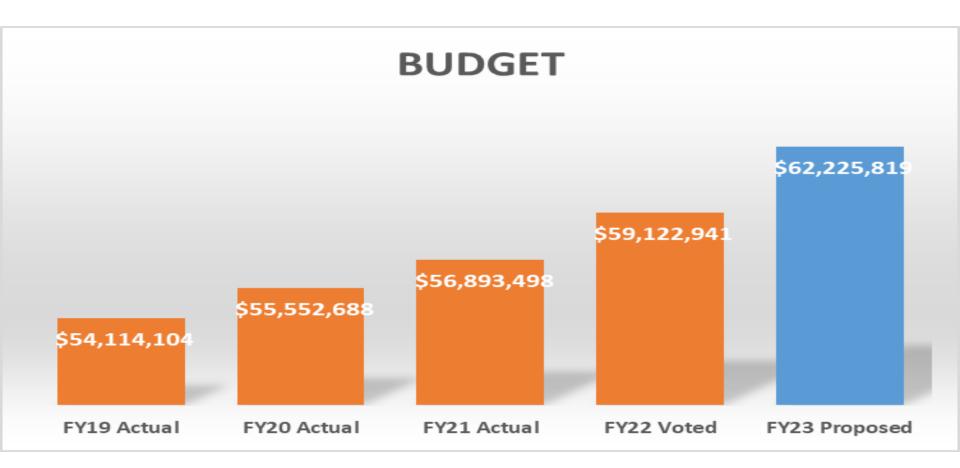

Total Budget Year over year



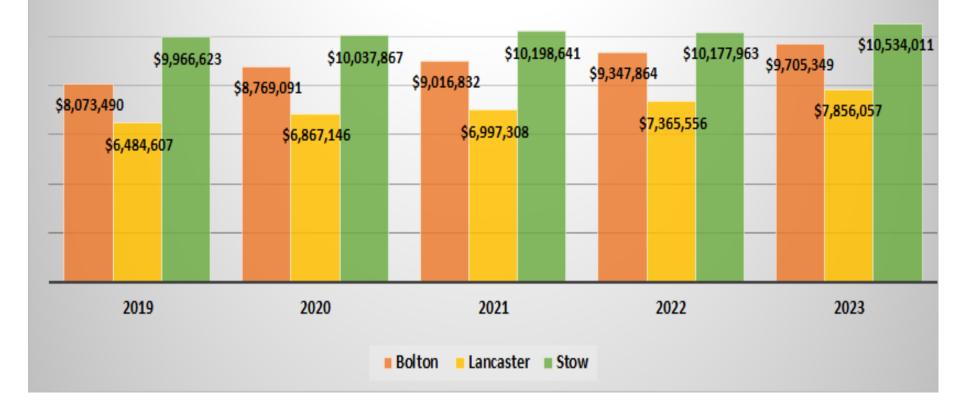

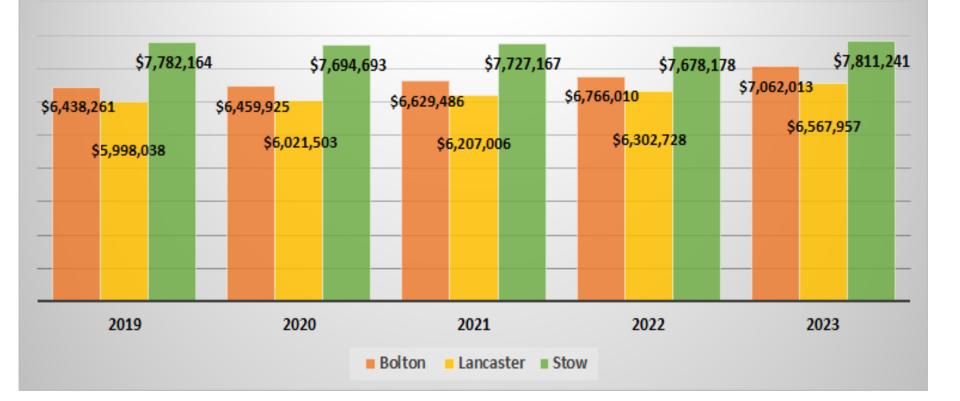

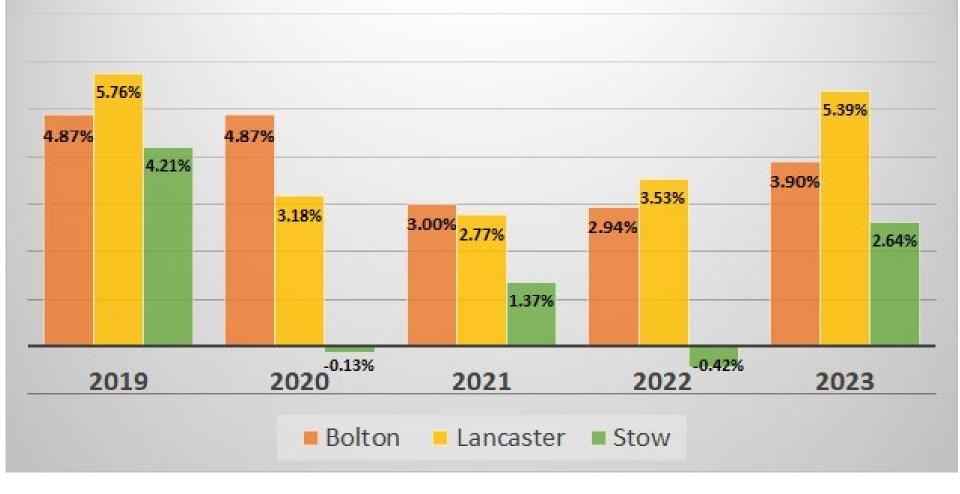

What is a Master Plan?

• Statutory Definition (M.G.L. Section 81D):

A Master Plan is "designed to provide a basis for decision making regarding the long-term physical development of a municipality"

- Long term: 10-15 year plan, a "Roadmap" for managing Bolton's development
- Resident-led, community plan
- Can be used as a basis for future funding requests

Master Plan Components



Why is a Master Plan update needed?

- 2006 Master Plan had a 20 year time horizon
 - Many recommendations already addressed; remaining need to be balanced with new priorities.
- Demographics and environment have changed
- Current input required of residents and Town government to revise priorities
- Town needs a refreshed and revised roadmap for its future

What work has been done so far?

- Developed overall plan & approach;
- Assembled task groups and developed work plans;
- Developed, distributed and analyzed initial **survey**;
- Completed research into current conditions;
- **Published pertinent findings** in digital & print media;
- Obtained limited consulting support through grants
- Conducted **initial public forum** and summarized results
- Developed & posted **RFP for further consulting services**

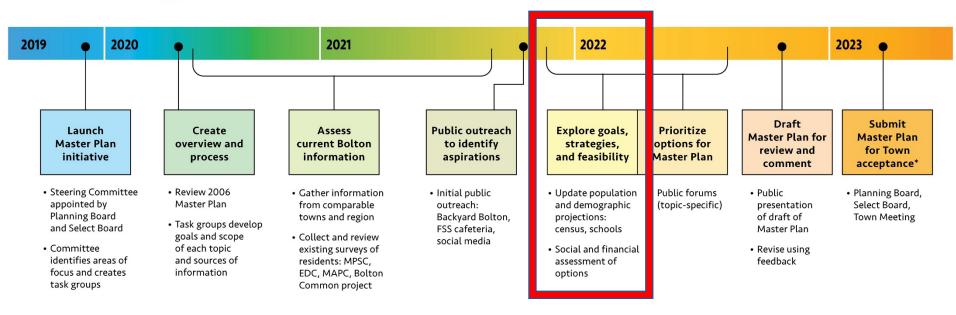

Bolton Master Plan: Process and Timeline



* Note: The Nashoba Regional School District is currently in the process of assessing the feasibility of reconstructing or newly constructing the High School (currently located on Green Road in Bolton). The Master Plan Steering Committee will adjust our overall timeline in order to incorporate key information and decisions from the High School project.

Why hire a consultant?

- Provide professional experience with Master Plan efforts across the region;
- Provide tools and technical assistance not otherwise available;
- Allocate dedicated staff to complete the project in an efficient, consistent & timely manner;
- Ensure high quality public outreach and engagement;
- Consolidate the individual elements of the Master Plan and provide a cohesive document in a "single voice"

What is the estimated cost for a consultant?

- Approximately \$120,000 150,000
 - Based on a survey of Master Planning budgets from Towns similar in size & development to Bolton

Additional Funding Sources

- Town Planner intends to request the Select Board allocate \$30,000 from ARPA Funds
- Town Planner will submit grant application to request \$75-100,000 through Housing Choice's Rural and Small Town Development Fund

Timing of Request

- Consultant selection is underway;
- Align with upcoming grant timeline to provide competitive application indicating a Town contribution;
- Provide initial funding to kick off activities under a consulting contract;
- Continue the Steering Committee's momentum to move the Master Plan forward as expeditiously as possible.

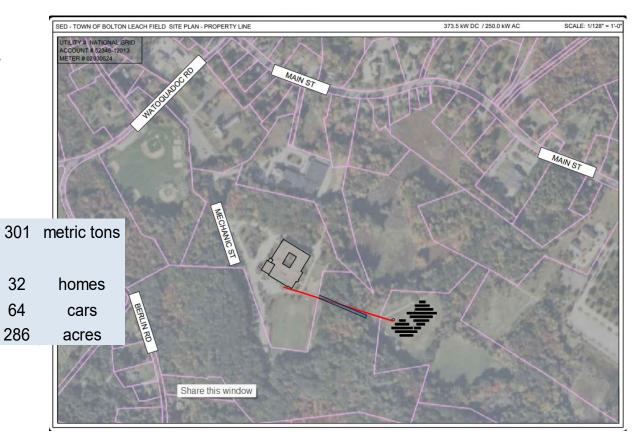

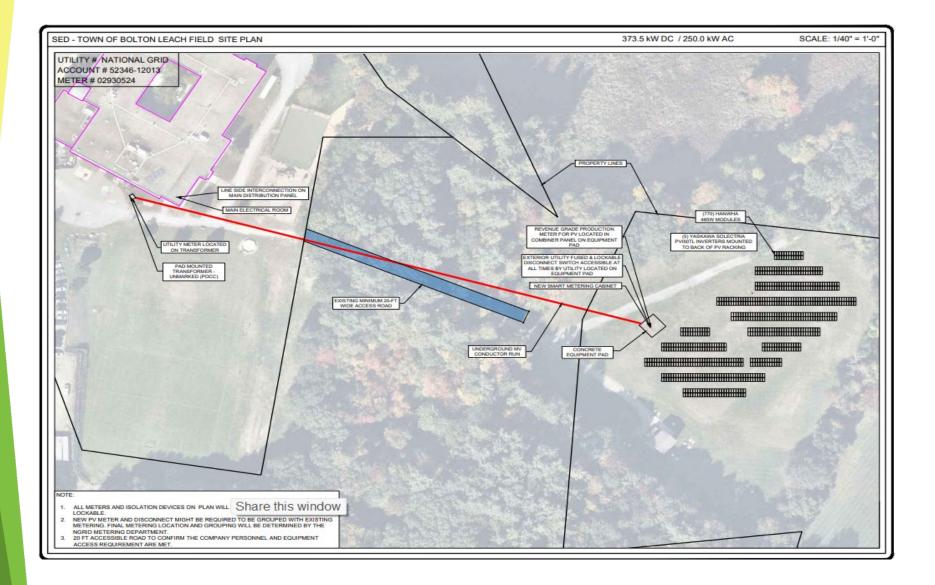
Leach Field Solar Array - Overview

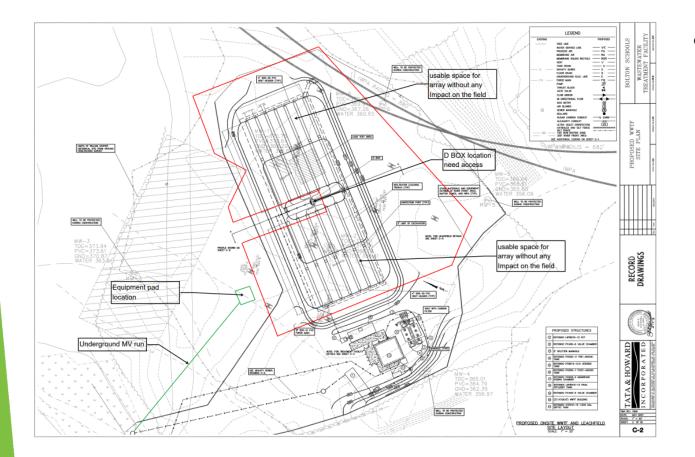

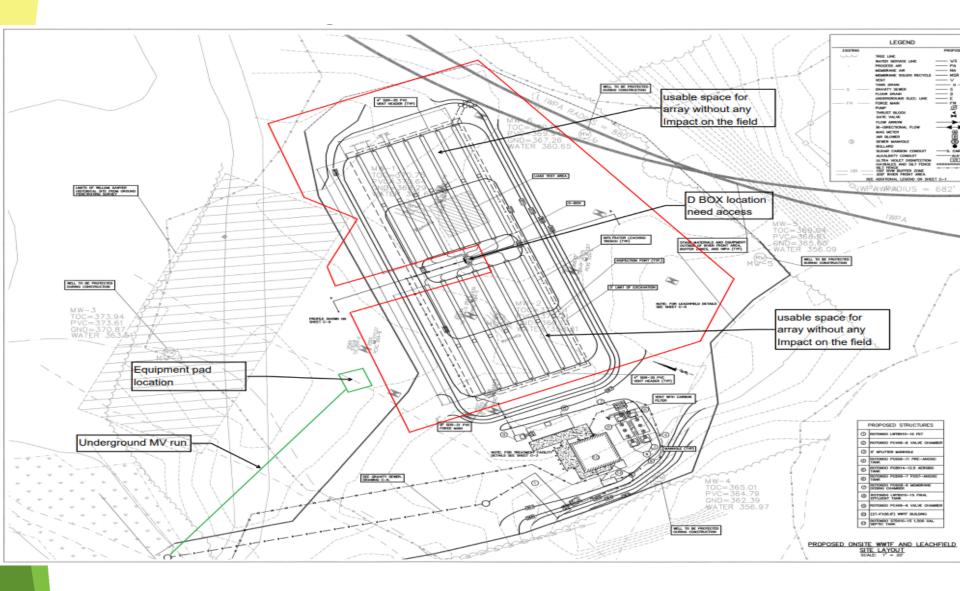




Leach Field Solar Array

 - leverage an existing underground conduit between the array area to the Sawyer school building to avoid construction in wetlands

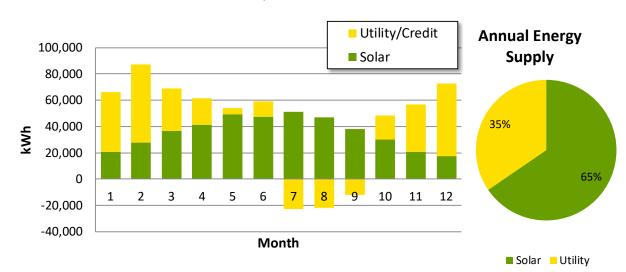


Leach Field – Solar Racking
