3.	 Friends of Persons Park Martha and Rona reported on the history and current condition of Persons Park. They requested Parks & Rec look into moving the sign from the current location down the driveway to the end of the driveway so it is visible from Route 85. Martha and Rona would like to pursue grants to fix up the cottage to make it into a fieldhouse to store equipment to support the park. The estimates from 4 years ago to fix up the cottage was \$150,000, and because of rising prices and further property deterioration, it is expected to be higher now. They requested that Parks & Rec support this effort to save the house and convert it to a fieldhouse. Parks & Rec does not have a need for storage in that location.
