The Board of Selectmen of the Town of Bolton hereby grant a special permit under the Water Resource Protection District of the ByLaws of the Town of Bolton for Thomas J. Flatley doing business as the Flatley Company project described in plans dated October 15, 1985 and subsequently updated or revised during 1986. In particular, the IEP, Inc. Site Plan for Bolton Office Park dated August 1986 is incorporated into this special permit by reference.

This special permit is granted for alteration of the Water Resource Protection District because the Selectmen have determined that the proposed alteration does not denegrate the intent of the bylaw. The permit is granted subject to the project's meeting all of the requirements in two related Town of Bolton documents which are incorporated by reference into this permit. These documents are:

Groundwater Alteration Permit dated September 29, 1986 granted by the Board of Health under the provisions of Bylaw 1.11 recorded at Book 10079, Page 292.

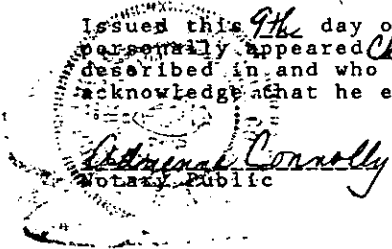
Order of Conditions 112-58 dated September 23, 1986 under the Wetlands Protection Act, Chapter 131 Section 40 recorded at Book 10014, Page 240.

Changes to any of the above referenced plans and permits and orders shall require a reapplication to the Board of Selectmen. This permit pertains to land described in a deed from Bell Development Company to Thomas J. Flatley doing business as the Flatley Company dated November 18, 1986 and recorded at Book 9994, Page 200.
