

APPLICATION FOR THE BOLTON SENIOR TAX REBATE PROGRAM

This is a local service program to enable residents of Bolton who are senior citizens to reduce property taxes by up to \$1,500.00 per household per year by working for the town of Bolton. Types of jobs routinely available include answering phones, computer work, filing, photocopying, typing and other clerical duties for various town departments. Please see website list for further examples.

To be eligible you must meet all of the following requirements:

- Age 60 plus.
- There are no income limits, but homeowners must have owned their home for one year prior to the fiscal year.
- Own and occupy the specific property for which taxes are paid and rebate is requested.

If I am accepted, I understand that I may earn a maximum credit of \$1,500.00 per year per household, which **can only be applied toward payment of my current Bolton real estate tax bill.** The figure of \$1,500.00 is calculated at 150 actual hours worked yearly times \$10.00 per hour. **The tax credit is applied once per year to the 4th quarter tax bill due May 1st.**
